Attached please find true and correct final information concerning the San Bernardino County Employees' Retirement Association Election.

The election was conducted under the supervision of MK Elections using the Electionbuddy internet voting system and the MK Elections paper balloting system. Voters opted whether to use paper ballots or to receive login credentials for the internet system by email.

MK Elections sent internet voting credentials at 9:00AM on November 5, 2024, and mailed paper ballots the same day. We monitored both systems throughout the open election period. MK Elections tracked the return of undeliverable ballots and mailed replacement ballots to voters upon their request and/or the request of the organization.

MK Elections completed the ballot count at the San Bernardino County Employees' Retirement Association office in San Bernardino, California starting at 9:30 A.M. on December 4, 2024. During the open period of the election, the ballots were returned to a post office box in San Bernardino and remained in the custody of the United States Post Office until the ballot pickup. Kenneth Mostern of MK Elections and Christa James of SBCERA were present and witnessed the ballot pickup at 9:00 A.M. on December 4. The scanning and counting processes were audited on real ballots to ensure that it was counting correctly. A crosscheck was performed to ensure that no voter voted on both paper and electronic systems.

Complete information about voters, undeliverables, replacement ballots sent, and other detailed information is available in the electronic files that accompany this report.

We certify that the attached results and ballot information attached are true and correct, and that they properly reflect the paper record of the election which has been sealed and kept in our custody.
