A motion was made by Mason, seconded by Waner, to Approve and adopt the proposed findings and recommendations of the referee regarding the Service-Connected Disability Retirement with Supplemental Retirement Allowance of Flora Adodo - Sheriff - County of San Bernardino. The motion carried by the following vote:

 Review and determine the Nonservice-Connected Disability Retirement with Supplemental Retirement Allowance of Marian C. Peterson - San Bernardino County - ARMC. <u>25-042</u>

A motion was made by Kennedy, seconded by Mason, to Approve Staff Recommendation 1, 2 and 4, but Amend 3, finding that Marian C. Peterson is permanently incapacitated for the performance of duties and a nonserviceconnected disability retirement should be granted. Marian C. Peterson is not capable of gainful employment; therefore, grant the supplemental disability retirement allowance. Staff shall initiate disability benefit payments with an effective date of July 24, 2024, date of application. The motion failed by the following vote:

- **Nays:** 4 Erickson, Fiorino, Waner, and Bracco

A motion was made by Waner, seconded by Bracco, to Approve Staff Recommendation finding that Marian C. Peterson is permanently incapacitated for the performance of duties and a nonservice- connected disability retirement should be granted. Marian C. Peterson is capable of gainful employment; therefore, deny the supplemental disability retirement allowance. Staff shall initiate disability benefit payments with an effective date of July 24, 2024, date of application. The motion carried by the following vote:
