

**SBCERA Resolution No. 2025-3**

**A RESOLUTION OF SAN BERNARDINO COUNTY EMPLOYEES' RETIREMENT ASSOCIATION (SBCERA) RECONFIRMING AND RESTATING INCLUSION OF ITS EMPLOYEES WITHIN THE COVERAGE OF ARTICLE 15.6 OF COUNTY EMPLOYEES' RETIREMENT LAW.**

**WHEREAS**, San Bernardino County Employees' Retirement Association is a California public retirement system, subject to the County Employees Retirement Law of 1937, as set forth in Government Code section 31450 et. seq.; and

**WHEREAS**, on March 31, 1975, the San Bernardino County Board of Supervisors, adopted Resolution No. R-75-47, implementing Article 15.6 of the CERL, thereby replacing Social Security coverage with survivor benefits for employees covered under the County's Social Security agreement, effective January 3, 1976; and

**WHEREAS**, by operation of Article 15.6, effective January 3, 1976, employees assigned to SBCERA became covered under provisions established by the Board of Supervisors; and

**WHEREAS**, effective July 5, 2008, SBCERA became a district as defined by Government Code section 31468(l)(2) pursuant to a Resolution by the SBCERA Board of Retirement (Board); and

**WHEREAS**, Government Code section 31522.5 and 31522.7 authorize the SBCERA Board to appoint designated management and personnel as employees of the retirement system, subject to applicable terms and conditions of employment; and

**WHEREAS**, employees of SBCERA participate as members in the SBCERA retirement system and are eligible to receive retirement benefits and related benefits, including survivor benefits payable to an eligible beneficiary under Article provided the

employee has completed at least eighteen (18) continuous months of credited service with SBCERA; and

**WHEREAS**, employees of SBCERA have continued to be included under the coverage of Article 15.6 following SBCERA's designation as a special district;

**WHEREAS**, the San Bernardino County Employees' Retirement Association Board of Retirement (Board) is required by Government Code section 31855.2 as a special district to include its employees within the coverage of Article 15.6.

**NOW, THEREFORE, BE IT RESOLVED**, that the SBCERA Board of Retirement hereby reconfirms and restates continued inclusion of the SBCERA employees within the coverage of Article 15.6 of the County Employees Retirement Law.

**IN WITNESS WHEREOF**, the above Resolution for SBCERA is hereby adopted by the BOARD on this 5<sup>th</sup> day of June, 2025.
