24. Review and determine the Service-Connected Disability Retirement with Supplemental Retirement Allowance of Mark D. Schrader - San Bernardino County - Sheriff. [24-463.1](#)

The Board directed staff to refer the matter to a fact finding hearing on the issue of permanent incapacity.

A motion was made by Bracco, seconded by Newcomer, to amend the staff recommendation finding that Mark D. Schrader is permanently incapacitated for the performance of duties and a service-connected disability retirement should be granted. Mr. Schrader is capable of gainful employment; therefore, denying the supplemental disability retirement allowance. The effective date will be February 13, 2024, date of application. The motion failed by the following vote:

A motion was made by Stafford, seconded by Bracco, to Approve the staff recommendation finding that Penny A. Carroll is permanently incapacitated for the performance of duties and a nonservice-connected disability retirement should be granted. Penny A. Carroll is not capable of gainful employment; therefore, granting the supplemental disability retirement allowance. Staff shall initiate disability benefit payments with an effective date of April 6, 2024, the day after the last day of regular compensation. The motion carried by the following vote:
