Subject: CEO Report - October 3, 2024 Board Meeting

Administration (Debby Cherney)

I'm happy to announce that SBCERA has once again received the prestigious Award for Excellence in Financial Reporting for our FY 2022-23 Annual Comprehensive Financial Report from the Government Finance Officers' Association of the United States and America. We'll plan to celebrate the achievement at an upcoming Board meeting.

Earlier this month, I attended the National Association of Government Defined Contribution Administrators (NAGDCA) annual conference in Phoenix, Arizona. Together with other members of the County's Defined Contribution (DC) oversight committee and members of the County's HR team, we attended sessions focused on best practices, lifetime income strategies, data sharing between the DB and DC plans, among other things. I walked away from the conference gratified that the DC committee's work to lower fees and streamline investment options is well-benchmarked to some of the best plans around.

We have identified applicants to invite to interview for the Cloud Infrastructure Architect and will be scheduling for the week of October 7, 2024. Stacey attended the inaugural Human Resources Summit hosted by National Conference on Public Employee Retirement Systems (NCPERS) in Denver, CO. She served as a Program Director with other public pension HR professionals from across the country to help build this event which brought together public pension human resources professionals for three days of networking, peer-to-peer learning, and hands-on training with industry experts. Stacey facilitated a discussion on Wednesday morning with Cara Woodson-Welch who is the CEO of the Public Sector Human Resources Association (PSHRA). They discussed the PSHRA 2024 Workforce Survey: Trends in Recruitment and Retention. Since 2009, PSHRA, the National Association of State Personnel Executives (NASPE), and MissionSquare Research Institute have partnered on a survey of HR managers around recruitment, retention, hard to fill positions, benefits changes, DEI, flexible workplace policies, and other key topics. Attendees learned how data from 2024 stacks up to prior years, where there's been post-pandemic improvement, and what strategies are most effective.







Investments (Don Pierce)

Investment performance for August 2024 came in as a positive 1%; however, that result trailed our policy benchmark performance of 1.9%. Despite an early August swoon in the equity markets where the S&P 500 was down over 6% in three days, markets rallied strongly the rest of August as the Federal Reserve all but confirmed a September rate cut and the S&P 500 ending up 2.4%. Bonds also rallied strongly as the prospect for rate cuts blossomed. SBCERA's existing credit portfolio continues to generate strong yield, and even if we assume a series of rates cuts from the Federal Reserve to something closer to 4.0%, this base interest level is still accretive to our overall portfolio.

Member Services (Christina Cintron)

This month, I officially stepped into the role of Chief of Member Services, and I am eager to lead our efforts in exploring innovative strategies to further elevate the service experience for our members and retirees while optimizing operational efficiency. Our team has been diligently processing applications for refunds and service retirements, as well as handling a high volume of member interactions through phone calls, message center requests, and emails. We remain committed to ensuring that each member receives the exceptional service they deserve.

Fiscal Services (Amy McInerny)

September was a typically busy month in Fiscal Services. In the course of four weeks, the team closed the books, created basic financial statements, nearly completed all field work with Brown Armstrong, and started on the supplemental materials for the Annual Comprehensive Financial Report. Speaking of financial reports, we have received notification from GFOA that SBCERA has been awarded the Certificate of Excellence for both the ACFR and PAFR for 2023.

Information Services (Joe Michael)

The Information Services Department released its largest service patch to the Pension Administration system to date. The service patch included expanded seminar functionality, fixes to minor system defects, and we began the integration of automating member request tracking via the online self-service tools. Previously, staff needed to update these trackers manually. With the new changes identified, processes will automatically advance the steps. The next service patch will bring new options in the way employers report data to us. This change is an upcoming addition and is one of the most significant employer-based enhancements we have made.

Staff have also begun to standardize the way in which we compile and release systems changes to staff. Focusing on our Pension Administration System, this new methodology once fully realized, will provide staff quick access to the latest changes and new functionality available to them. In addition, the documentation will be stored in such a manner as to be a framework for possible AI utilization in the future.

Comment sheets, Domestic Relations Order reviews, and Joinders were fairly consistent in August and September. There was a 50% decline in Disability Retirement Applications received from August to September. However, there were no applications rejected in September due to untimeliness or incompleteness. This may show that members are becoming more comfortable with the new application. Half of the Disability Retirement Applications received were submitted through the MySBCERA portal. There was an increase in active death payroll setups due to staff concentrating on clearing backlog.
