Re: San Bernardino County Employees' Retirement Association Cost-of-Living Adjustments (COLA) as of April 1, 2020

Dear Debby:

We have determined the cost-of-living adjustments for the Association in accordance with Section 31870, as provided in the enclosed exhibit.

The cost-of-living factor to be used by the Association on April 1, 2020 is determined by comparing the November CPI for the Riverside-San Bernardino-Ontario Area (with December 2017 as the base period) in each of the past two years. The ratio of the past two November indices, 106.573 in 2019 and 103.616 in 2018, is 1.0285. The County Law section cited above indicates that the resulting percentage change of 2.85% should be rounded to the nearest one-half percent, which is 3.0%.

Please note the above cost-of-living adjustment calculated using established procedures for SBCERA may result in adjustments different from those calculated using alternative procedures by other systems.

The actual cost-of-living adjustment is independent of the date of retirement. The CPI adjustment to be applied on April 1, 2020 is provided in Column (4) of the enclosed exhibit. The COLA bank on April 1, 2020 is provided in Column (5).
