**RECOMMENDATION:**

Approve the Service-Connected Disability Retirement application of Maria Mercedes Padilla - San Bernardino County - Sheriff.

**Requested Benefit:**

1. Service-Connected Disability Retirement

**Staff Recommendation:**

1. Maria Mercedes Padilla is permanently incapacitated for the performance of duties and a disability retirement should be granted.
2. Maria Mercedes Padilla's disability is service-connected based on the claimed injury (ies)/disease as listed in Exhibit A; therefore, grant a service-connected disability benefit.
3. Maria Mercedes Padilla is not capable of gainful employment; therefore, grant the supplemental disability retirement allowance.
4. Staff shall initiate disability benefit payments with an effective date of September 23, 2023, the day after the last day of regular compensation.
