RECOMMENDATION:

Approve the Service-Connected Disability Retirement application of Justin P. McLean - County of San Bernardino - Sheriff.

Requested Benefit:

- 1. Service-Connected Disability Retirement

Staff Recommendation:

- 1. Justin P. McLean is permanently incapacitated for the performance of duties and a disability retirement should be granted.
- 2. Justin P. McLean’s disability is service-connected based on the claimed injury(ies)/disease as listed in Exhibit A; therefore, grant a service-connected disability benefit.
- 3. Staff shall initiate disability benefit payments with an effective date of July 6, 2019, the day after the last day of regular compensation.
