SUBJECT: Disability Retirement Application of Dianne Timm

RECOMMENDATION:

Review and determine the Service-Connected Disability Retirement with Supplemental Retirement Allowance of Dianne Timm - County of San Bernardino - Behavioral Health.

Requested Benefit:

1. Service-Connected Disability Retirement with Supplemental Retirement Allowance

Staff Recommendation:

- 1. Dianne Timm is permanently incapacitated for the performance of duties and a disability retirement should be granted.
- 2. Dianne Timm's disability is non-service connected based on the claimed injury(ies)/disease as listed in Exhibit A; therefore, grant a non-service connected disability benefit.
- 3. Dianne Timm is not capable of gainful employment; therefore, grant the supplemental disability retirement allowance.
- 4. Staff shall initiate disability benefit payments with an effective date of March 31, 2018, the day after the last day of regular compensation.
