SUBJECT: SACRS Board of Directors Elections 2020-2021

RECOMMENDATION:

Appointment of and provide direction to a Voting Delegate and Alternate Voting Delegate for the SACRS Board of Directors Electronic Election.

BACKGROUND:

In light of COVID-19, the State Association of California Retirement Systems (SACRS) is conducting its 2020-2021 Board of Directors Election electronically.
