SUBJECT: Disability Retirement Application of Danielle A. Hasberry

RECOMMENDATION:

Review and determine the Service-Connected Disability Retirement with Supplemental Retirement Allowance of Danielle A. Hasberry - Human Services - County of San Bernardino.

Requested Benefit:

1. Service-Connected Disability Retirement with Supplemental Retirement Allowance

Staff Recommendation:

- 1. Danielle A. Hasberry is permanently incapacitated for the performance of duties and a disability retirement should be granted.
- 2. Danielle A. Hasberry's disability is non-service connected based on the claimed injury (ies)/disease as listed in Exhibit A; therefore, grant a non-service connected disability benefit.
- 3. Danielle A. Hasberry is capable of gainful employment; therefore, deny the supplemental disability retirement allowance.
- 4. Staff shall initiate disability benefit payments with an effective date of April 29, 2017, the day after the last day of regular compensation.

BACKGROUND:

At the November 5, 2020 Board of Retirement meeting, the Board granted a continuance for Ms. Hasberry to provide additional documentation in support of her claim of service-connected disability retirement.
