**SUBJECT:** Disability Retirement Application of Alma Martinez

#### **RECOMMENDATION:**

Review and determine the Service-Connected Disability Retirement with Supplemental Retirement Allowance of Alma Martinez - San Bernardino County - Behavioral Health.

#### **Requested Benefit:**

1. Service-Connected Disability Retirement with Supplemental Retirement Allowance

Staff Recommendation:

- 1. Alma Martinez is permanently incapacitated for the performance of duties and a disability retirement should be granted.
- 2. Alma Martinez's disability is non-service connected based on the claimed injury(ies)/disease as listed in Exhibit A; therefore, grant a non-service connected disability benefit.
- 3. Alma Martinez is not capable of gainful employment; therefore, grant the supplemental disability retirement allowance.
- 4. Staff shall initiate disability benefit payments with an effective date of August 1, 2020, the day after the last day of regular compensation.
