#### **RECOMMENDATION:**

Review and determine the Service-Connected Disability Retirement with Supplemental Retirement Allowance of Juanita Weiss - San Bernardino County - Probation.

### Requested Benefit:

1. Service-Connected Disability Retirement with Supplemental Retirement Allowance

#### Staff Recommendation:

- 1. Juanita Weiss is permanently incapacitated for the performance of duties and a disability retirement should be granted.
- 2. Juanita Weiss' disability is non-service connected based on the claimed injury(ies)/disease as listed in Exhibit A; therefore, grant a non-service connected disability benefit.
- 3. Juanita Weiss is not capable of gainful employment; therefore, grant the supplemental disability retirement allowance.
- 4. Staff shall initiate disability benefit payments with an effective date of June 8, 2019, the day after the last day of regular compensation.

#### **BACKGROUND:**

At the May 5, 2022 Board meeting, the board granted an extension to June 2, 2022 for the member to obtain legal representation. Juanita Weiss retained Kristen Zierhut as her attorney.
